Introduction and Recommendation

The Division received an application (Exhibit A) for the repair of 17 hazardous monuments located in the East Side Cemetery, town of Chateaugay, Franklin County. The application was submitted by Kevin Legacy, president of the East Side Cemetery Association. Included with this application was an estimate, from North Country Masonry (Exhibit B) totaling \$24,000, and a letter stating that Mr. Legacy had contacted both Upstate Monument Company and St. Lawrence Valley Concrete seeking bids (Exhibit C). After several requests, neither contractor submitted a bid. Also included was an invoice from The Malone Telegram for a legal notice (Exhibit D) that was run for three consecutive weeks from, August 6, through August 20, 2019, for \$75.33.

I recommend approval of this application.

The Monuments

The East Side Cemetery was visited, and all 17 monuments were found to be either loose on their foundations or tipping and appeared to pose a hazard to cemetery visitors and employees. Mr. Legacy stated that the cemetery has no records for the monuments in question and as such, could not contact the last known lot owners by mail, the most recent monument is dated 1982. The cemetery has had no response to the legal advertisements which it placed, and has no funds dedicated to the restoration of monuments. Based upon the information provided, it is the Division's understanding that the cemetery has determined that the monument owners cannot be found.



The Estimate

North Country Masonry proposes to: remove the monuments from the existing foundations; dig out existing foundations; place new foundations made of solid concrete poured to a depth of 48 inches and replace the monument, resealing all joints with setting compound or epoxy and offer a ten-year warranty.

Recommendation

The Cemetery is up to date on annual reports and vandalism payments. This appears to be a legitimate claim for \$24,075.33. I recommend that this application be approved.
