#### INTRODUCTION

Governor Andrew Cuomo established the County-wide Shared Services Initiative ("CWSSI") in the FY18 State Budget with the stated intent of generating tax savings through inter-government collaboration. This statewide initiative requires the chief executive officers in the 57 counties outside of New York City to convene Shared Services Panels for the purpose of identifying and developing shared services projects. The projects are then then incorporated into a Shared Services Plan and put up for a vote by the Shared Services Panel.

The Shared Services Panel must consist of the chief executive officer of every city, town and village in the county. For Genesee County, this creates a working Shared Services Panel of at least 21 officials. This panel could be expanded to include any school district, board of cooperative educational services, fire protection or special district representatives in the county. Development of a Shared Services Plan will also require the input from the public, and from civic, business and labor leaders.

The Countywide Shared Services Initiative (CWSSI) requires the County Manager to convene at least three (3) public meetings in advance of the delivery of a Shared Services Plan to the panel for a vote. The process will be organized and administered by the County and the inter-governmental panel will be chaired by the County Manager, L. Matthew Landers.

The goal of the CWSSI is to save property taxpayers money, by identifying collaborative opportunities for shared services between as many local governments as possible. Prospects for both short-term and long-term savings should be considered.

An effective Shared Services Plan that expands inter-governmental collaboration and maximizes local tax savings through the shared services projects it includes will require meaningful participation from all stakeholders. Genesee County Officials look forward to working together for the benefit of our residents and taxpayers.

The County may opt to invite any school district, board of cooperative educational services, fire district, fire protection district, or special improvement district in the county.

#### KFY ROLES & RESPONSIBILITES

#### Role of the County Manager's Office

- Staff the panel and represent the County and its residents
- Commence meetings and consult with the required panel members
- Organize public hearings and topical meetings with key strategic partners
- Develop and submit the plan, estimated Cost Savings Certification for County Legislature review
- Submit the final approved plan with certification to the NYS Division of the Budget
- Present the final approved plan to the public

#### Role of Municipal Partners (City, Town and Village Representatives)

- Represent their local government and residents on the Shared Services Panel
- Participate in plan development and provide local costs and savings estimates
- Collaborate with other panel members and recommend actions for implementation
- Determine if your municipality should opt-out of any actions proposed in the plan
- Vote on the plan and provide written reasons for your vote

#### **Plan Contents**

The plan must contain new, recurring property tax savings from actions such as, but not limited to:

- Elimination of duplicative services;
- Shared Services, such as joint purchasing, shared highway equipment, shared storage facilities, shared plowing services, and energy and insurance pushing cooperatives;
- Reductions in back office administrative overhead; and
- Better coordination of services.

Savings from each new plan action implemented in the applicable match year must be related to activities supported by property taxes. Net savings from services supported solely by fees are not eligible for matching funds from the state.

The final approved plan must include a certification of savings to be achieved through implementation of the shared services actions. For Genesee County's plan that will be submitted in 2020, the certified savings will be tracked and documented for **new actions taken on and after January 1, 2021 through December 31, 2021.** 

#### **Outline of the Genesee County CWSSI Process**

The following is an outline of the meetings and milestones that will move Genesee County and the municipal partners through the development and submission of the Shared Services Plan while meeting the timing and public notifications required under the Governor's initiative.

Please note, the panel must hold at least two (2) panel meetings, followed by at least three (3) public hearings prior to submission of the plan to NYS. The outline that follows provides the meeting dates held for panel meetings.

#### PROPOSALS FOR CONSIDERATION

**PROPOSAL ONE: Pharmacy Purchasing Coalition** 

Participating Municipalities: Genesee County and the Capital Region BOCES

Anticipated Annual Savings: \$1,000,000

The Capital Region BOCES pharmacy purchasing coalition is a self-insured prescription drug program designed to aggregate purchasing of pharmacy benefits and was initially developed with grant funding for the Department of State. The program is designed to comport with nearly any health insurance plan and benefit structure that a municipality may have. Further, potential savings for members is not impacted by the size of any municipality choosing to participate. Since the program was developed in 2012, savings for members has exceeded \$68 million dollars. Average savings per coalition member has been 10-20% of their current pharmacy cost.

Genesee County intends to implement this initiative on January 1, 2021. The leg work of the project has been started. Genesee County did learn about the coalition during the RFP for pharmacy administrative services. The RFP selection committee and Genesee County Legislature are supportive of the plan to move forward by entering into contract. A transition phase between pharmaceutical plan administrators will occur. Plan beneficiaries may experience a small disruption during the first three months of the year.

The coalition has a proven record of saving members due to the volume of participants the group receives higher rebates on pharmaceuticals and reduced prices than smaller/single organizations. The anticipated annual savings is based on the current utilization matrix for active plan participants.

#### PROPOSAL TWO: Pavilion / LeRoy Shared Court Facility

Participating Municipalities: Town of Pavilion and the Town of LeRoy

Anticipated Annual Savings: \$28,700

The Town of Pavilion Judges will utilize LeRoy's facilities including bailiff, metal detector, and courtroom. This will eliminate the duplication of these items from Pavilion's court department. Because of the very short hours of Pavilion's court activity keeping a paid bailiff for an additional hour will be less money than contracting separately with one.

The participating municipalities intend to implement this initiative in January 2021. A signed shared services agreement between Pavilion and LeRoy and an operational plan of how the facility will be effectively shared to benefit both towns. Estimated cost savings include \$1,200 a year for the reduction of a Court Bailiff and \$7,500 a year for the reduction of a Court Clerk. Additional, this proposal includes cost avoidance savings totaling \$20,000 in necessary facility improvements.
