Shared equipment, personnel, and services; Joint purchasing.

**Summary:** Share resources to assist local code enforcement officers in inspecting and reporting on unsafe buildings and collapsed structures, as well as share resources between municipalities and/or jointly procure contract(s) for maintenance, repair, and demolition services.

Shared services agreement(s) may also contemplate jointly procuring specialized equipment that may not be cost effective for a single municipality to purchase for its sole use.

Amount of Savings: \$120,000

#### 3. Software and Subscription Sharing

Shared equipment, personnel, and services; Joint purchasing.

#### 4. Anti-bias, Diversity, and Inclusion Training for Public Officers and Employees

Shared equipment, personnel, and services; Joint purchasing.

**Summary:** Jointly purchase annual training services to provide anti-bias, diversity, and inclusion training for public officers and employees, which may also include crisis intervention training for law enforcement officers.

Amount of Savings: \$30,000

#### 5. Animal Control Services across Municipalities

Shared equipment, personnel, and services; Joint purchasing.

Monroe County, Brighton, Chili, East Rochester, Gates, Greece, Henrietta, Honeoye Falls, Irondequoit, Mendon, Ogden, Parma, Penfield, Town of Pittsford, Village of Pittsford, Rush, Spencerport, Town of Webster, and/or Village of Webster.

**Summary:** Share resources between municipalities and/or jointly procure contract(s) for animal and/or dog control services, including but not limited to licensing and kenneling services.

Amount of Savings: \$190,000

## 6. Renovate Chili Town Hall into Town Court, and consolidate with court(s) of adjacent municipalities

Shared equipment, personnel, and services.

#### Participating Municipalities:

Towns of Rush, Ogden, Gates, Riga, and/or Wheatland.

**Summary:** Chili is renovating its Town Hall into its Town Court and will have extra space that could be utilized for other court services for adjacent municipalities. The Town of Chili and one or more towns that form a contiguous geographic area within Monroe County may explore: (1) establishing a single justice court; or (2) seeking Home Rule Legislation permitting the other town(s) to hold all court proceedings in the Town of Chili.

Amount of Savings: \$120,000

#### 7. Shared Recreation Program(s)

Shared equipment, personnel, and services.

#### Participating Municipalities:

Amount of Savings: \$75,000

## 9. Extend Sewer and Potable Water to Monroe County Fair Site and surrounding vicinities

Shared equipment, personnel, and services.

<u>Participating Municipalities:</u> Monroe County, Towns of Rush and Henrietta.

**Summary:** Rush and Henrietta will explore forming a joint sewer district and/or otherwise share or jointly procure shared equipment, personnel, and services.

Amount of Savings: \$90,000

## 10. Countywide Intermunicipal Agreement for purchasing and sharing equipment

Shared equipment, personnel, and services.

#### Participating Municipalities:

**Summary:** Enter into intermunicipal agreement to create a joint purchasing schedule and sharing of said equipment.

Amount of Savings: \$150,000

#### 11. Crossing Guards

Shared equipment, personnel, and services.

#### Participating Municipalities:

Town of Brighton, Brighton Central School District, Town of Penfield, Penfield Central School District, Town of Pittsford, Pittsford Central School District, Town of Henrietta, Rush-Henrietta Central School District, and/or Wheatland-Chili School District.

**Summary:** The Town of Brighton and one or more of the school districts that support Brighton residents will explore sharing resources and/or jointly procuring contract(s) to provide crossing guard services.

Amount of Savings: \$26,000
