### 22-10-A-75 Minutes of Previous Meetings

Motion was made, seconded, and unanimously adopted approving the minutes of the Board's September 20, 2022 meeting.

# 22-10-B-76 Legislation and Regulations

1. Legislation

Mr. Vanderbles stated that there is nothing to report. Mr. Polishook added that the Town of Ellicottville wrote in opposition to legislation proposed by Sen. Addabbo and Assembly Member Hevesi.

2. Regulations

No update.

# 22-10-C-77 Division Report

Division Director Lewis Polishook reported as follows:

- 1. Staffing: we have hired one Senior Accountant in Albany (out of two vacancies); he will start in two weeks. We still seek to fill the second position, along with a temporary position for an Associate Accountant and an Administrative Assistant in Albany.
- 2. All but two cemeteries have reported on their certificates of indebtedness or land share certificates; we will review the submissions.
- 3. We are fast approaching annual report season.
- 4. Report on cemeteries at risk of abandonment: This is our second quarterly report on cemeteries at risk of abandonment. One of the cemeteries listed in the report as at risk of abandonment, Bear Ridge Cemetery in Niagara County, had a successful special lot owners meeting on Saturday, October 8, and should be characterized as no longer at risk. Eleven cemeteries are at risk of abandonment, of which three are likely past the point of no return. We are trying to determine if they meet the definition of abandonment; we are missing information for two of them that we would need to determine that they are abandoned. We have assisted in preventing abandonment, at least for now, of fourteen cemeteries using our process of working with lot owners, boards, and towns. Mr. Pattison asked about lessons learned; Mr. Polishook responded that two of the cemeteries were saved from abandonment via posts on social media, and that local officials are best suited for identifying new cemetery directors.
- 5. Investigator application: The application, which will allow for inputting data in the field, is done; we are working on deployment.

Assistant Director Alicia Young reported that we have received approximately 40% of annual reports online.

### 22-10-D-78 Vandalism, Abandonment and Monument Repair or Removal Fund Report

Assistant Director Alicia Young provided the vandalism report and referred the Board to it. She noted that of the \$2 million dollar appropriation for this fiscal year, if we had to pay out all of the applications previously

approved, currently before the board, and in the pipeline, we would exhaust our appropriation, but payments will not all be made in this fiscal year.

There is one application for the Board today, totaling \$37,284.20, involving dangerous monuments.

### 33-043, Oriskany Falls Cemetery (Oneida County), \$37,284.20

This cemetery seeks funds to repair hazardous monuments. After discussion, a motion was made, seconded, and unanimously adopted approving the application by this cemetery for funds to repair 31 hazardous monuments in the amount of \$37,284.20, subject to availability of funds.

# 22-10-E-79 30-005 Locust Valley Cemetery – Major Renovation

This cemetery in Nassau county seeks approval of a major alteration to build a new storage and maintenance building at an estimated cost of \$203,901, to come from the cemetery's general fund.

After discussion, a motion was made, seconded, and unanimously adopted approving the application, subject to receipt of stamped plans.

# 22-10-F-80 33-056 South Trenton Cemetery – Land Sale

This cemetery seeks to sell a 5.2-acre parcel of land that is not contiguous to developed areas of the cemetery, for \$23,000.

After discussion, a motion was made, seconded, and unanimously adopted approving the sale.

### 22-10-G-81 60-006 Ferncliff Cemetery – Additional Niches

This cemetery seeks to install 1,056 glass-front niches in an existing mausoleum building, for a total estimated cost of \$480,380 to come from the cemetery's general fund.

After discussion, a motion was made, seconded, and unanimously adopted approving the application, subject to the cemetery not receiving any adverse comments concerning the project by October 15, 2022.

#### **Public Comment**

David Fleming, for the New York State of Cemeteries, asked that the Board consider delegating to the Division authority to approve applications such as the one presented by Ferncliff at this meeting, because delays in approval can affect prices.

Motion was made, seconded, and unanimously adopted adjourning the meeting.
