22-09-C-73 Division Report

Division Director Lewis Polishook reported as follows:

- 1. We will report on the status of abandonments next month.
- 2. We will be asking the board to delegate to the Division retort replacement applications to the Division.
- 3. A new accountant, Steven Troutman, started in our Binghamton office this month; we continue interviews to fill Albany vacancies.
- 4. We will be requiring cemeteries to report on the status of certificates in their annual reports starting next year; we also asked cemeteries for information about their certificates for this year; responses are due September 22.
- 5. At the New York State Association of Cemeteries' fall conference in Cooperstown, several investment advisors offered to give guidance to smaller cemeteries; we cannot recommend investment advisors but suggest that smaller cemeteries contact NYSAC for help concerning investment strategies.

Assistant Director Alicia Young reported that we have received approximately 40% of annual reports online.

22-09-D-74 Vandalism, Abandonment and Monument Repair or Removal Fund Report

Assistant Director Alicia Young provided the vandalism report and referred the Board to it.

There are two applications for the Board today, totaling \$75,405.86, both of which involve dangerous monuments.

19-010, Evergreen Hill Cemetery (Madison County), \$41,187.74

This cemetery seeks funds to repair hazardous monuments. After discussion, a motion was made, seconded, and unanimously adopted approving the application by this cemetery for funds to repair 31 hazardous monuments in the amount of \$41,187.74, subject to availability of funds.

34-014, Frumah Packard Cemetery (Onondaga County), \$34,218.12
