NOTICE OF PUBLIC HEARING Environmental Facilities Corporation

Notice is hereby given that the New York State Environmental Facilities Corporation (the "Corporation") will hold a public hearing pursuant to the Internal Revenue Code of 1986 as amended on the proposed financing of water management facilities for The New Rochelle Water Company (the "Company").

The Corporation is empowered under the New York State Environmental Facilities Corporation Act (Title 12 of Article 5 of the Public Authorities Law, as amended) to issue tax exempt, special obligation revenue bonds and notes and to lend the proceeds from these bonds and notes to finance pollution control, water management and certain other facilities. All bonds issued will be special obligations of the Corporation payable solely from revenues derived by the Corporation pursuant to a loan agreement by and among the Corporation, the Company and General Waterworks Corporation (the "Applicant").

Applicant: General Waterworks Corporation, a Delaware corporation ("General Waterworks"), 2004 Renaissance Boulevard, King of Prussia, PA 19406-2758. The proceeds of the bonds will be made available to the Company, a wholly owned subsidiary of General Waterworks.

Project: The Applicant has requested a loan not to exceed \$18 million to finance the acquisition, construction, and installation of various facilities for the supply, control, treatment and distribution of water in New Rochelle, New York and surrounding communities all of which are located in Westchester County. The project includes the following improvements to land, machinery, equipment and facilities: add/or replace water mains in order to improve fire flow availability in various sections of the distribution system; install a membrane filtration plant within the system to demonstrate the feasibility of this technology as a possible solution for treating surface water source of supply; and certain additional or substituted facilities and appurtenances, furnishings, equipment and machinery for the supply, control, treatment and distribution of water.

Public Hearing: All persons, organizations, corporations and government agencies are invited to submit comments on the proposed project. The hearing will be held on July 8, 1992 at 2:00 p.m. in Room 438, 4th Fl., 50 Wolf Rd., Albany, NY.

PUBLIC NOTICE Department of Environmental Conservation

The Department of Environmental Conservation hereby gives public notice of its intention to approve a hazardous packaging exemption pursuant to Environmental Conservation Law, section 37-0207(2).

This two-year exemption is being granted to The West Company, a manufacturer of glass ampoules designed to contain FDA-regulated pharmaceutical preparations for the health care industry. Such ampoules are decorated with ceramic labeling ink which contains (typical maximum amounts) of 650 parts per million (ppm) of lead and 40 ppm of cadmium.

STATEWIDE — Pursuant to 15 CFR 923.84 (b), the New York State Department of State (DOS) hereby gives notice that the Federal Office of Ocean and Coastal Resource Management (OCRM) concurred on May 27, 1992 on the incorporation of the Village of Piermont Local Waterfront Revitalization Program (LWRP) into the State's Coastal Management Program (CMP) as a routine program implementation action. DOS requested OCRM's concurrence on this action on January 10, 1990 in a previous notice in the *State Register* which further described the content of the action.

Pursuant to the State CMP and Article 42 of the Executive Law, the Village's LWRP was adopted by the Village on January 7, 1992 and approved by the New York State Secretary of State on February 18, 1992.
