IN FY 20-21

The following is a brief summary of collected fees and payments of funds granted from the Vandalism, Abandonment and Monument Repair or Removal Fund. The vast majority of monies are collected concurrent with the submission of annual reports, generally filed within the first three months of the calendar year.

2020 calendar year vandalism collections are \$458,627. Assessment collections are \$261,525. Fiscal year collections from April 1, 2020 are: Vandalism \$74,295. Assessment \$44,693.

The entire \$2,000,000 2019/20 appropriation was spent by March 31, 2020. \$483,067.74 is still unpaid from prior years applications. \$287,385.69 has been paid on FYE 2019/20 applications from the \$2,000,000 2020/21 appropriation. \$85,042.18 has been paid on the \$401,559.47 applications approved in FYE 2020/21. Leaving \$827,987.10 available for future applications from the 2020/21 appropriation.

- 1 Abandonment applications - \$ 36,634.00

### Annual Reports

1,299 annual reports have been received for 2019.

We have received 380 annual report on-line submissions for the 2019 reporting year, representing 29% of all reports filed.
