The following is a brief summary of collected fees and payments of funds granted from the Vandalism, Abandonment and Monument Repair or Removal Fund. The vast majority of monies are collected concurrent with the submission of annual reports, generally filed within the first three months of the calendar year.

The vandalism collections for calendar year 2023 are \$497,625. Assessment collections were \$272,530. Fiscal year collections from April 1, 2023, are: Vandalism \$74,873. Assessment \$39,337, as of June 8, 2023

We received confirmation of the \$2,000,000 appropriation for the 2023-2024 fiscal year.

There remains \$85,092.56 of funds committed for 2018/19 and 2019/20 applications and \$47,613.60 committed for applications approved in the 2020/21 fiscal year. Outstanding payments for the 2021/22 fiscal year total \$15,663.21. Outstanding payments for the 2022/23 fiscal year totals \$536,515.23.

Currently there are 17 applications in the pipeline for approval totaling \$474,228.39. There are seven applications on the agenda for this meeting.
