FY 2024-25

The following is a brief summary of collected fees and payments of funds granted from the Vandalism, Abandonment and Monument Repair or Removal Fund. The vast majority of monies are collected concurrent with the submission of annual reports, generally filed within the first three months of the calendar year.

The vandalism collections for calendar year 2024 are \$540,032.78. Assessment collections are \$293,882. Fiscal year collections from April 1, 2024 through March 31, 2015, are Vandalism \$98,442.00. Assessment \$51,522.00.

The appropriation for the 2024-2025 fiscal year is \$2,000,000.

There are applications that the Cemetery Board approved in previous years that we have not paid in full yet, either because the cemeteries have not completed the work or for other reasons. There remains \$71,129.54 of funds committed for 2018/19 and 2019/20 applications and \$47,613.60 committed for applications approved in the 2020/21 fiscal year. There are no outstanding payments for the 2021/22 fiscal year. Outstanding payments for the 2022/23 fiscal year totals \$52,780.67. Outstanding payments for applications approved in the 2023/24 fiscal year total \$685,238.39.
